The following notification will be published in the Andhra Pradesh Gazette dated: 07-03-2013.

**NOTIFICATION**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh hereby make the following amendments to the Andhra Pradesh Technical Education Sub-ordinate Service Rules issued in G.O.Ms.No.76, Higher Education (TE.2) Department, dated: 20<sup>th</sup>, October, 2003 and as amended from time to time.

**AMENDMENTS**

**In the said rules:**

- (1) For the words “Zone-VII” wherever they occur, the words “City Cadre (City of Hyderabad)” shall be substituted.
- (1) In the Table under rule 2 in Class “C”, the posts Physical Director and Librarian mentioned against categories 1 and 2 shall be omitted.
- (2) In the Table under rule 3 in Class “C” the categories of posts (1) Physical Director and (2) Librarian mentioned in columns (1) and the corresponding entries made against them in columns.(2) and (3) shall be omitted.
- (3) In the proviso to rule 4 the words “and also the Physical Directors in Women Polytechnics” shall be omitted.
- (4) In the Annexure under rule 5 in Class “C” the categories of posts (1) Physical Director and (2) Librarian mentioned in column (1) and the corresponding entries made against them in columns (2) and (3) shall be omitted.
